Terms & Conditions:

1. General Terms & Conditions:

- 1.1 The Agency should have a valid GST registration certificate under the relevant act.
- **1.2** Any other taxes which become leviable over and above the statutory provision at the time of billing shall be borne by MAHA-METRO.
- **1.3** In all correspondences and payment instructions/instruments, the full name of the organization is to be mentioned.
- **1.4** Any other works in addition to the works which are already identified above can be taken up at mutually agreed terms & conditions, based on the discussions as required.
- **1.5** In case any major deviations in terms of quantities, methodology, etc., are required to be made to the present scope due to changes in site conditions, Client's requirements etc., the contractor shall discuss the same with client to arrive at suitable revisions in the enlisted terms and conditions.
- 1.6 Maha-Metro will issue the Award of Work in writing to the successful Agency. The work will be awarded to the Agency offering the lowest evaluated proposal in conformity with the requirements of these conditions and Maha-Metro shall be the sole judge in this regard notwithstanding anything contained herein and without prejudice to its rights.
- **1.7** The prices quoted by the contractor for the entire scope of the work shall be treated as the Contract Price. No escalation/reduction of any nature in contract price will be allowed during the duration of the contract.
- **1.8** The contract can be terminated if the contractor does not perform to the Satisfaction of Maha-Metro after being given a notice of seven days.
- **1.9** The contractor will exercise all reasonable skills, care and diligence in the performance of the services and shall carry all the responsibilities in accordance with recognized professional standards.

2. Specific Terms & Conditions:

- **2.1** The offer shall remain valid for a period of Two Months, from the date of issuance of notice for this quotation. Validity of offer is extendable on mutual consent.
- 2.2 Bidder shall quote his offer in percentage in the BOQ provided above.

2.3 Taxes & Duties :-

- **2.3.1** The Contract Price is inclusive of applicable GST, which should be mentioned separately in your invoice, as per prevailing rules and GST act, at the time of billing.
- **2.3.2** Statutory deduction shall be done as per prevailing norms.
- **2.3.3** TDS towards Income Tax, etc. leviable under the applicable laws shall be deducted by Maha-Metro at the time of payment of any amount for this work. Details of taxes deducted/Tax deduction certificate at the source shall be issued to the Agency/Supplier along with the final bill.
- 2.3.4 The contract price shall include Transportation, Lifting and Positioning of rail trolley at Viaduct.

2.4 Security Deposit :-

- 2.4.1 An amount of total 5% Security Deposit will be recovered through the1st bill at the time of payment.
- **2.4.2** This amount of security deposit shall be forfeited by Maha-Metro if Agency/Supplier fails to correct any defect or replace/redo any defective works during the Warranty Period.
- 2.4.3 This security deposit shall be released after successful completion of Warranty period.

2.5 Payment Terms:-

- **2.5.1** An amount equal to 20% of contract price shall be payable to contractor as an advance after furnishing of security deposit in the form of demand draft of an equal amount to MAHA METRO.
- **2.5.2** Payment shall be done on measurement basis as per BOQ provided and after successful completion of work and satisfactory review by officials of Maha-Metro. Total advance money will be recovered from the contactor at the time of first payment of RA Bill.
- 2.6 Warranty Period/Defect Liability Period shall be 12 Months from date of issue of LOA/Work Order.
